

# General Terms of Service

## 1 stand registration

The registration for the event takes place on the form "stand registration". The form must be filled in carefully and signed legally binding. The registration is an irrevocable contract offer to GABS UG, to which the exhibitor is bound until the beginning of the event.

### 1.2 Contractual content

Essential components of the contract are

- a) the registration form,
- b) the special conditions of participation,
- c) the regulations contained in the exhibitor service documents,
- d) the terms and conditions.

In the case of non-compliance, the regulations apply in the above-

### 1.3 Inclusion of the terms of contract

By signing the stand application recognizes the exhibitor the business and

Conditions of participation as well as in contained in the Exhibitor Service Documents

Regulations as binding. He is responsible for ensuring that the people employed by him at the event also receive the entire contract.

## 2 conclusion of contract

The organizer decides about the acceptance of the offer by a written Order confirmation (approval of the exhibitor and the registered exhibits).

## 2.1 Restriction of exhibitors and exhibition goods

For justifiable reasons, in particular if the available space is insufficient, the organizer may exclude individual exhibitors from participation and limit the event to certain groups of exhibitors if this is necessary for the purpose of the event. The same applies to the exhibits.

## 3 principles

The organizer divides the booth Consideration of the topic and the structure of the respective event as well as the available premises. Stand requests are considered if possible.

### 3.1 Exchanges, transfer to third parties

An exchange of allocated booth with another exhibitor and a part or complete release of the Status to third parties is without corresponding Agreement with GABS UG not allowed.

## 4 exhibits

Only the agreed exhibits can be exhibited

### 4.1 Exclusion

The organizer may request that exhibits be removed in the event Stand rental agreement was not included or as annoying or dangerous prove or with the event goal are incompatible. Will the desire

GABS UG does not comply with the judiciary

Help at the expense of the exhibitor.

4.2 Exhibits are marked with clearly legible price tags.

In particular, the exhibitor must procure and comply with the industrial and sanitary permits.

## 5 terms of payment

The booth rental according to the order confirmation is up to the dates specified in the special conditions of participation, quoting the invoice number, on one of the organizers' accounts indicated on the invoice.

The amounts are invoiced due.

### 5.1 assignment, offsetting

The assignment of claims against The organizer is excluded. The Offsetting of claims is only possible with indisputable or legally established Counterclaims allowed.

### 5.2 Complaints

Complaints of the bills can only be considered if they are within 14 days after invoice in writing to the organizer.

5.3 The exhibitor is liable according to the legal requirements Provisions. The conclusion of a Exhibitor insurance is recommended.

## 6 Non-participation of the exhibitor

The stand rental is also to be paid in full if the exhibitor cancels his participation or does not participate in the event without such cancellation.

If the exhibitor declines his participation and succeeds in letting the stand otherwise, the organizer reserves the right to a cost share of 25% of the stand rental invoiced to the first tenant. The full stand rental is payable if the organizer re-releases the agreed stand space, but the total rental space is reduced by the cancellation / non-attendance.

The exhibitor reserves the proof that the organizer has not incurred these costs or not at this amount. The assertion of further claims remains reserved.

## 7 Resignation of the organizer

The organizer is entitled to resign, if

- a) the full rental payment has not been received by the time specified in the invoice at the latest and the exhibitor is not after expiry a grace period set for him pays;
- b) the exhibitor violates the house right and does not cease his behavior even after a warning;

## 8 Failure of the event

Can the organizer due to a In the event that neither the exhibitor nor the exhibitor is responsible for the event, they will not be entitled to the stand rental.

## General Terms of Service

### **8.1 Started event**

If the organizer has to shorten or cancel an event due to the entry of force majeure, the exhibitor is not entitled to repayment or cancellation of the stand rental.

### **9 house right**

During the event, the exhibitor is subject to the house right of the organizer on the entire site.

### **9.1 parking spaces**

Parking requirements of the exhibitors on the exhibition grounds are taken into account as far as possible. A claim to a parking space does not exist.

### **9.2 Access to the festival area**

During the event, vehicles that do not have a permit do not have access to the indoor area. The delivery of goods and the like is regulated in the conditions of participation.

### **10 environmental protection**

The exhibitor is obliged to behave in an environmentally sound manner.

### **11 appearance**

The exhibition stand must be adapted to the overall plan of the exhibition. The organizer reserves the right to prohibit the construction of inadequate or insufficiently designed stands.

### **12 data protection regulations**

The exhibitor agrees that the organizer stores, processes or forwards personal data and business data in accordance with the Federal Data Protection Act, also using automated data processing for business purposes, as far as this is the case

### **13 Final provisions**

#### **13.1 written form**

Deviations from the content of this contract as well as additional agreements are only legally binding if they have been confirmed in writing by the organizer.

#### **13.2 German law**

The mutual rights and obligations arising from this contractual relationship and on the occasion of this contract are subject to the law of the Federal Republic of Germany.

#### **13.3 Jurisdiction**

The court of jurisdiction is the district court Horb a.N

#### **13.4 Statute of limitations**

Claims by the exhibitor against the organizer become statute-barred after 3 months unless otherwise required by mandatory statutory provisions.
