Participation Terms

Stand allocation

- A stand setup can only be possible when the total payment is completed
- Deviation of the stand size must be permitted from the organiser
- Claims can only be made on the registered space in the market
- Exhibitors without registration will not be allowed at the festival grounds

Liability

Insurance is the responsibility of the exhibitor

Organisation

- Loud music at stands after 11.00pm is forbidden
- Exhibitor must comply with the police regulations (Opening time, music, hygienic rules)
- The Promoter reserves sanctions or exclusion from the market by failure to comply with the Market Rules.

Infrastructure

- Electricity and water connections must be declared.
- Stall fittings are the responsibility of the exhibitor (e.g stalls, tent, tables, chairs, etc)

Waste disposal

- The exhibitor shall be responsible for cleaning his stand and disposing of waste during the stand construction and dismantling periods, and throughout the duration of the Festival. Failure to do so will not get his deposit refunded.

Conditions of payment

- Payment is due within 14 days of receipt of the invoice unless the invoice specifies otherwise. Until the rental fee has been paid in full, the exhibitor will not receive the confirmation allowing admission to the festival grounds for a stand set-up.

Payment without deduction is to be made in the bank details printed on the invoice.

- Complaints regarding invoices shall be sent in writing to GABS UG within an exclusion period of 14 days after receipt of the invoice.
- If payment is made after the due date or in other cases of delayed payment, our claims shall be determined in accordance with § 288 German Civil Code (BGB).

The distribution of printed materials

The distribution of printed materials and/or advertisements outside of the stands is prohibited and subject to approval by project management for a fee.

Withdrawal

The withdrawal from the contract for any reason is not allowed. The event takes place in all weather conditions. The exhibitor has no right to demand a discount in case of bad weather.

Applicable law / Place of execution / Place of Jurisdiction

Only the law of the Federal Republic of Germany applies for all the legal relations
